The Friends of the Strand Theatre subsidizes these events by offering special discounted rates to non-profit organizations in order to support their events and fundraising efforts, and also to provide a venue on Main Street where such community events can be centrally located. The subsidized rates allow the renting organizations the flexibility to make their events free or low-cost as well as enabling them to re-invest the funds raised from the events into their own budgets.
